

# Official T-Shirt Design Contest Rules for Brew City Showdown's 10<sup>th</sup> year anniversary

## Official Contest Rules

I have read the OFFICIAL CONTEST RULES for the Brew City's 10<sup>th</sup> Annual Showdown design contest and I agree to all the rules and regulations of the contest as outlined below:

1. The contest is open to anyone who wants to participate.
2. All entries must be original creations of the contestant that incorporates any of Metro or Brew City Blades brand (i.e. colors, trademarks, or logos) into the design, has never been published, and does not contain profanity, trademarks, logos, or copyrighted works of any other person or business.
3. **The prize is free t-shirt, bragging rights at the tournament, a 12 pack of beer, and free tournament entry (up to \$50).**
4. The winning design will remain the property of Metro Milwaukee Women's Hockey (Metro), and will not be returned to you. Metro may use the winning design at any time after the contest. The winning design may display their own design in a portfolio or personal collection, but may not sell or reproduce the design for any other purpose once submitted to the contest.
5. A panel of judges representing Metro will choose the top submissions. The top submissions will be put to a public vote from **March 25<sup>th</sup> through April 1<sup>st</sup>**.
6. The contest begins on **February 10<sup>th</sup>, 2018**.
7. The entries must be sent to [brewcityshowdown@gmail.com](mailto:brewcityshowdown@gmail.com) by **11:59pm on Sunday, March 25<sup>th</sup>, 2018**.
8. There is no limit to the number of entries that can be submitted by an individual.
9. FORM OF ENTRIES:
  - o The entry should be accompanied by your name and contact information.
  - o The entry may be drawn or printed on 8-1/2" x 11" paper or the entry may be any of the following art file formats if submitted electronically: .AI, .JPG, .PDF, .PNG or .PSD. (Dimensions: 12" x 12")
  - o Design must be limited to a single color for printing purposes.
10. Metro reserves the right to pick one entry, more than one entry, or no entries as the winning entry.
11. If your entry is selected as the winning entry, the winning contestant who created the winning entry will receive a free t-shirt, bragging rights at the tournament, a 12 pack of beer, and free tournament entry (up to \$50).
12. Metro reserves the right to terminate this contest at any time, effective on the date of issuing the termination notice, and we are under no obligation to give notice prior to the date of termination.
13. You agree that if you submit an entry, you will sign an assignment and release form prepared by us acknowledging your acceptance and understanding of the complete contest rules including that the winning design is the property of Metro.
14. This contest is subject to all federal, state and local laws.
